


### Quick Facts about TCAs

- The average active TCA volunteered 61.39 hours just this year
- Over 50 Tree Care Advisors are also First
  Detectors
- Over 40 Tree Care Advisors are or have been a Tree Inspector

Over 350 volunteers have walked through the doors of the TCA program since 1993. These volunteers, up to the end of 2013, have put in a total of 81,915.13 volunteer hours. They volunteer for their state, their county, their city and for non-profits who need them. In 2013 alone TCAs volunteered 5,176.93 hours.



Tree Care Advisors volunteer in a variety of ways. In 2013, more hours were dedicated to tabling events, tree inventory, and teaching adults.

#### Money Talks: Measuring Volunteers in Dollars

The group, Independent Sector, has calculated an hourly dollar rate for volunteer contributions. This rate has not been updated since 2011, but it still demonstrates the magnitude that volunteers contribute. The hourly rate for 2011 is carried forward in table below to 2012 and 2013. Based on 2011 figures, the amount per hour is \$21.91, resulting in \$1,464,525.56 for the volunteer work done by TCAs from 1993-2013. This is money the state, counties, cities and non-profits are saving.
